Anelto Limited Warranty

Effective December 1, 2018

"Anelto Products" covered under this limited warranty may include Personal Emergency Response Systems (PERS), Mobile Personal Emergency Response Systems (MPERS), Remote Patient Monitoring Systems, and Telehealth Equipment; and any other hardware or accessories sold by Anelto.

General Disclaimers

- 1. For proper operation, the Anelto Products require adequate cellular coverage. Poor cellular coverage may result in the inability to place a call.
- 2. In an emergency, User should provide the response team with as much information as possible about User's location.
- 3. The Anelto Products are not a replacement for User's regular contact with caregivers or access to an alternative means of placing an emergency call.
- 4. While the fall detection system performs well, if available and enabled, no such system is 100% reliable. If User experiences a fall that causes actual or potential injury, do not wait for the automatic call. User should always press the call button manually if able.
- 5. The Anelto Products require adequate battery charge for proper operation. Low battery may result in the inability to place a call, automatically detect a fall, and/or properly locate User automatically during an emergency.
- 6. The Anelto Products utilize Global Positioning System (GPS), WIFI Location (WIFI) and network Location Based Services (LBS) in order to find User's current location. By activating an Anelto Product, User agrees to allow Anelto and its affiliates to use this information to provide services to them in the case of an emergency response.
- 7. The Anelto Products provide User's location to a response center in order to respond to an event requiring assistance. By activating an Anelto Product, User agrees to allow such Anelto Product to provide the response center with User's location.
- 8. The Anelto Products may use GPS technology to identify User's location. In good conditions, this technology should provide a location that is accurate within 30 feet or less. However, performance of GPS can be affected by a wide range of factors, including obstructions, metal objects in the vicinity, structures that block the signal from satellites, weather, and other factors outside of Anelto's control.
- 9. By activating an Anelto Product, User consents to the use of his or her personally identifiable information as described in Anelto's privacy policy and notice, located at www.anelto.com at the bottom of each page.
- 10. The Anelto Product lanyards are designed to break apart under certain conditions; however, any cord worn around the neck can pose a risk of strangulation, including the possibility of serious injury or death.
- 11. Anelto Products do not provide medical advice. User should always consult his or her physician or other healthcare professional with any questions regarding any medical or mental health condition, or for specific guidance regarding nutrition or physical activity.

Anelto Product Warranty

Anelto warrants to the User ("User" or "you") that the Anelto Products will be free from defects in workmanship and materials, under normal use and service, for 12 months from the date of original sale (the "Warranty Period").

Anelto's sole obligation under this express warranty shall be, at Anelto's option and expense, to repair the defective product or part, or deliver to the User an equivalent product or part to replace the defective item. All returned products will become the property of Anelto.

This warranty does not cover:

1. Defects or damage as the result of use of any Anelto Product in other than its customary purpose;

- 2. Defects or damage from misuse, accident, water or neglect;
- 3. Anelto Products that have been subjected to unauthorized modifications;
- 4. Anelto Products that have had their serial numbers removed or made illegible;
- 5. Shipping costs to send any such product to Anelto's repair center(s);
- 6. Devices that, due to illegal or unauthorized alteration of the software/firmware in the product, does not function in accordance with Anelto's published specifications of the FCC type acceptance labeling in effect for the device at the time the new device was initially distributed by Anelto:
- 7. Scratches or cosmetic damage to the Anelto Product's surface that do not affect operation of the device:
- 8. Normal and customary wear and tear; and/or
- 9. Devices that have been previously used or remanufactured.
